#### OVERVIEW

- The HSGP is a primary funding mechanism for building and sustaining national preparedness capabilities.
- The HSGP supports preparedness activities that address high priority preparedness gaps across all core capabilities that support terrorism preparedness activities, including planning, organization, equipment purchase, training, exercises, and management and administration across all core capabilities and mission areas. The basis for funding projects must have a nexus to terrorism
- FY 2022 HSGP Period of Performance 36 Months (3 Years)
  - Period of Performance Start and End Date(s): September 1, 2022 to August 31, 2025
- No match required
- The HSGP is comprised of three interconnected grant programs (SHSP, UASI and OPSG).

#### **State Homeland Security Program (SHSP)**

- This program provides funding to support the implementation of risk-driven, capabilities-based State Homeland Security Strategies to address capability targets.
- 80/20 Split (80% to Counties 20% to State) with 30% supporting law enforcement agencies and national priorities

#### **Urban Area Security Initiative (UASI)**

- This program provides funding to enhance regional preparedness and capabilities in designated high-threat, high-density
  areas.
- City and County of Honolulu is the only recipient of the UASI

#### **Operation Stonegarden (OPSG)**

• This program provides funding to enhance cooperation and coordination among state, local, tribal, territorial, and federal law enforcement agencies to jointly enhance security along the United States land and water borders

# Build America Buy America Act (BABAA)

## **Background**

- Effective January 2, 2023, all infrastructure projects funded with Federal Awards must be in compliance with the BABAA
- Construction material sources such as; iron, steel, lumber, concrete must be purchased/ manufactured in the United States
- Examples of infrastructure projects; structures, facilities, roads, highways, dams, ports, harbors, rail roads, water and sewer systems



## **OVERVIEW**

- On September 16, 2022, the Department of Homeland Security (DHS) announced the first cybersecurity grant program specifically for state, local, and territorial (SLT) governments across the country.
- The State and Local Cybersecurity Grant Program (SLCGP) provides funding to eligible entities to
  address <u>cybersecurity risks</u> and <u>cybersecurity threats</u> to information systems owned or operated
  by, or on behalf of, state, local, or tribal governments.
- FY 2022 SLCGP Period of Performance 48 Months (4 Years)
  - Period of Performance Start and End Date(s): September 1, 2022 to August 31, 2026
- Requirements (FY 2022)
  - Establish a Cybersecurity Planning Committee;
  - Develop a state-wide Cybersecurity Plan, unless the recipient already has a state-wide Cybersecurity Plan
    and uses the funds to implement or revise a state-wide Cybersecurity Plan;
  - Conduct assessment and evaluations as the basis for individual projects throughout the life of the program; and Adopt key cybersecurity best practices.

# FY 2022 SLCGP Objectives:

#### Objective 1: Governance and Planning

 Develop and establish appropriate governance structures, including developing, implementing, or revising cybersecurity plans, to improve capabilities to respond to cybersecurity incidents and ensure continuity of operations.

#### Objective 2: Assessment and Evaluation

Understand current cybersecurity posture and areas for improvement based on continuous testing,
 evaluation, and structured assessments.

#### Objective 3: Mitigation


Implement security protections commensurate with risk.

#### Objective 4: Workforce Development

 Ensure organization personnel are appropriately trained in cybersecurity, commensurate with responsibility.




#### **NSGP OVERVIEW**

# **Purpose**

The Non-Profit Security Grant Program (NSGP) provides federal funding support for facility hardening and physical security enhancements and other security related activities to Non-Profit organizations that are at high risk of a terrorist attack.

- NSGP is a Competitive Grant
  - Applicants will be scored
- NSGP period of performance is 36 months
  - Projected Period of Performance Start Date(s):
     September 1, 2023 to August 31, 2026



- Valid Employer Identification Number (EIN)
- Non-Profit with 501(c)(3) Organizations such as churches, mosques, and synagogues are considered
- Active registration in System for Award management (SAM) at https://sam.gov. Entity must have an assigned SAM Unique Entity Identifier (UEI) assigned.
- High Risk for Terrorist Attacks
  - Be able to demonstrate, through the application, that the organization is at high risk of a terrorist attack due to their ideology, beliefs, or mission.
    - Describe any incidents that have occurred at the facility.
    - Describe any threats (e.g., verbal threats, vandalization) made against the organization.
    - Current events with specific attention to incidents impacting organizations that have been targeted due to a similar mission, belief, or ideology.
- Each applicant may apply for up to three different sites
  - Each site requires an Investment Justification form to be completed
  - Projects for each site should not exceed \$150k

What type of entities / organization are eligible to apply under the NSGP?

Eligible organizations are registered 501(c)(3) nonprofits or otherwise are organizations as described under 501(c)(3) of the Internal Revenue Code (IRC) and tax-exempt under section 501(a) of the IRC. The list below is not exhaustive and only provides examples of potential eligible organizations, all of which must be nonprofits.

#### **Enduring Needs**

- Planning:
  - Security Plans and Protocol
  - Emergency Contingency Plans
  - Evacuation Shelter in Place Plans
- Training and Awareness:
  - Active Shooter Training
  - Security training for employees, or members / congregation
  - Public awareness / preparedness campaigns
- Exercises:
  - Response exercises

## **SECURITY VULNERABILITY ASSESSMENT OVERVIEW**

- Cybersecurity and Infrastructure Security Agency (CISA)
  - CISA conducts a security assessment of the facility online or onsite
  - The security assessment is required as part of the application submission
  - Security Assessment provides a road map in the development of your investment justification



  - State Administrative Agency (SAA) review
  - Federal Review
- Results used to inform the final funding decision made by the Secretary of Homeland Security

# APPLICATION SUBMISSION CHECKLIST

- ✓ Register Entity in the SAMS Portal at <a href="https://sam.gov">https://sam.gov</a>. Must have a Unique Entity Identifier # Assigned
- ✓ Non-Profit organization must conduct a vulnerability Security assessment for each proposed site
- ✓ Non-Profit organization must complete the Investment Justification Form
  - ✓ Provide a Mission Statement (Used to validate information in the IJ and to categorize the facility (ideology-based, education, medical, and other)
  - ✓ Supporting Documentation, if applicable (Materials to help validate/support content of vulnerability assessment and investment justification, such as police or insurance reports. Reach out to your SAA to better understand any state level requirements, processes, templates, timelines, etc)
- ✓ Non-Profit to submit the completed Investment Justification, Mission Statement and any supporting documentation to the State Administrative Agency (SAA) (HIDOD /OHS) for review
- SAA will submit the Investment Justification application to the DHS/FEMA before the deadline (May 2023 tbd)

  - 6) Exercises.



- Eligible applicants:
  - Port Authorities
  - Facility operators: Examples of facility operators include, but are not limited to terminal operators, ferry systems, bar/harbor pilots, and merchant's exchanges.
  - State and local government agencies.
  - Private sector partners
- Investments must support port areas (maritime security).
  - Support increase port-wide risk management and protect critical surface transportation infrastructure from acts of terrorism



- A single eligible entity may submit only one application within each port area.
  - An application may contain up to five (5) investments
- Cost Match
  - For profit entities must provide a 50 percent match
  - State / Local Government entities must provide a 25 percent match
  - Example: Total project Cost: \$300k
     \$225,000 75% Federal Portion
     \$75,000.00 25% Cash Match (out of own entity's expense)



- Valid Employer Identification Number (EIN)
- Active registration in System for Award management (SAM).
   Entity must have a SAM Unique Entity Identifier (UEI) assigned.
- \* An eligible entity applying for the grant does not guarantee grant funding



# **APPLICATION REVIEW PROCESS**

- State
  - The local U.S. Coast Guard Captain of the Port (COPT) reviews, prioritized projects and will rate projects after submittal
  - COPT makes recommendation to the DHS /FEMA
- Federal
  - Review
  - Final Scoring
  - Award

Obtaining an UEI number	Four weeks before actual submission deadline
Creating an account with login.gov	Four weeks before actual submission deadline
Registering in SAM or Updating SAM registration	Four weeks before actual submission deadline
Registering in Grants.gov	Four weeks before actual submission deadline
Starting application in Grants.gov	Four weeks before actual submission deadline
Submitting initial application in Grants.gov	One week before actual submission deadline
Submitting the final application in ND Grants	By the submission deadline
