**PROPOSED ADOPTION OF CHAPTER 24-1000, HAWAII  
ADMINISTRATIVE RULES, ENTITLED "ADDRESS  
CONFIDENTIALITY PROGRAM"**

Pursuant to Chapter 91, Hawaii Revised Statutes (HRS), notice is hereby given that the Department of Law Enforcement (DLE) will hold a public hearing as follows:

**Background:** The purpose of the proposed rules are to provide standards and procedures for participation in the Address Confidentiality Program set forth in chapter 801G, HRS. The program assists survivors of domestic abuse, a sexual assault, or stalking to keep their residential, employment, or school address confidential in state and county agency records.

All interested persons are invited to attend the public hearing to state their views, orally and/or in writing on the proposed rules for adoption. All comments received will be reviewed by the DLE, and subsequent amendments may be considered, if appropriate.
